Thank you for another year of support and dedication to improving animal welfare across South Australia.

It's been just over a year since we moved into our Animal Care Campus at O'Halloran Hill, a milestone that marked not just a change in location, but a transformation in how we care for animals and support our people.

While the transition came with its share of unexpected hurdles, we've embraced the opportunity to refine our facilities and create a space that offers better accommodation for animals and a more united environment for our staff and volunteers.

Looking ahead, we're excited to continue expanding our campus. Plans are underway to build additional animal housing, enhance walking trails, and nurture native flora. Thanks to the generosity of our patron supporter, Carole Stone, we're also introducing a dedicated dog park for our resident canines, which will be a space designed for enrichment and socialisation.

But our capacity to care isn't measured solely by infrastructure. It's defined by the dedication of our people. From veterinary professionals and behaviour specialists to Inspectors, customer care teams, and volunteers, we've invested in growing our workforce to ensure best-practice standards across every aspect of our operations.

This year, our team has faced increasing demand. Cost of living pressures have led to a rise in reports of neglect and abandonment, and more families are seeking help to stay with their pets or surrender them when no other option exists. In the 2024-2025 financial year, we received 5,125 reports of cruelty or neglect and welcomed 6,257 animals into our care.

Despite the strain, we've responded with resolve; finding forever homes for 3,348 animals. We've also expanded our Inspectorate, recruiting 2 new Inspectors with plans to add one more, bringing our total to 11 in the coming year.

Our Foster Program continues to be a cornerstone of our work, with 2,139 animals placed in loving foster homes last year. Foster carers help us to extend our reach beyond the shelter and provide animals with the comfort and stability of a home environment.

In early 2025, we formalised our community outreach initiatives to meet emerging needs. The Pet Pantry now offers food and supplies to families in crisis, while Vet Assist provides financial support and micro-loans for veterinary care, ensuring pets and their people can stay together during difficult times. These programs have already had an incredible impact in keeping families united when they need each other most.

Beyond direct care, our advocacy efforts have continued to shape the future of animal welfare. We've led the charge against duck hunting, with a petition set to be presented in late 2025. We played a key role in developing South Australia's first state-wide Cat Management Plan, which brings much-needed clarity and cohesion to cat ownership and welfare. We're also working with government to advance long-overdue amendments to the Animal Welfare Act, which will bring stronger protections for animals and tougher penalties.

In the year ahead, we'll continue to push for legislative reform, an end to duck shooting, and greater scrutiny of industries that exploit animals for sport and gambling; particularly the greyhound racing sector, where meaningful change remains slow. We will keep asking the hard questions about whether a social license can ever truly exist for animals in sport.

As we prepare to celebrate 150 years of RSPCA South Australia, we do so with immense pride in what we've achieved, and deep gratitude for the community that makes it all possible. Whether you've donated, volunteered, adopted, fostered, shopped, signed a petition, or simply shared our stories, your actions have helped drive change.

On behalf of our team, our Board, and the animals we serve, thank you.










Highlights



One year in our new home

In May 2024, we officially opened our purpose-built Adelaide Animal Care Campus (AACC) at O'Halloran Hill, marking a transformative moment for RSPCA SA. Uniting our teams together onto one multi-purpose campus has undoubtedly enhanced the quality of care we deliver. Our wonderful staff and volunteers continue to work side by side; sharing knowledge and resources more effectively than ever before. Our campus is home to modern animal accommodation, the Brad Ward Veterinary Clinic, and there are more fantastic developments in the works. AACC truly represents a hub for rescue and enforcement, uniting our mission under one roof and setting a new benchmark for animal welfare in our state.

Final Million Paws Walk -The Last Lap - the end of an era

In May 2025, we hosted our final Million Paws Walk, marking the end of a beloved national tradition that spanned three decades. Held at the Adelaide Botanic Garden, the event brought together 2,766 people and their pooches, raising over \$100,000 for animals in need. The final walk celebrated many years of community spirit, compassion, and dedication, with more than 750,000 participants and 400,000 dogs raising \$17 million since its inception. The Last Lap was a fantastic tribute to the owners and pups who helped shape a legacy of kindness and care!



Approaching our 150-year milestone

As we we near the end of 2025, we find ourselves reflecting on a truly remarkable milestone: 150 years of unwavering dedication to animal welfare. This landmark anniversary honours the generations of staff, volunteers, and supporters whose compassion and courage laid the foundation we continue to build upon. From our origins in 1875, sparked by public concern for mistreated horses and bullocks, RSPCA South Australia has grown into a vital force for change; underpinned by our collective love for all creatures great and small. We remain deeply grateful to those who came before us, carrying forward their legacy with heart and conviction. Their mission to protect animals from cruelty still drives every action we take today.

Growing our Inspectorate Team

In mid-2024, we welcomed a landmark commitment from the state government: \$16.4 million over four years in funding for our incredible Inspectorate Team through to 2028. Thanks to this support, we will continue to expand our team, improve response capacity, and prepare for upcoming legislative changes. We also allocated \$2.5 million to build new enclosures at our care campus to meet the increasing number of animals coming into our care via the Inspectorate Team. Our heartfelt thanks go to the Inspectorate Team, whose tireless work investigating cruelty and neglect continues to protect thousands of animals each year.



In a major win for animals across South Australia, the state government passed its biggest animal welfare law update in 16 years, bringing stronger protections for animals and and tougher penalties for offenders. Backed by community support, this reform marks a major step forward for animal wellbeing across our state. When implemented, the updated laws will introduce Australia's toughest penalties: up to \$250,000 or 10 years' jail for severe harm, and fines for businesses reaching \$1 million.

Once the new regulations are in place, the updated Animal Welfare will allow us to proactively enforce animal care standards, engage with pet owners to prevent harm, and prosecute cruelty cases much faster.

Celebrating RSPCA volunteers

RSPCA SA proudly celebrated its volunteers in 2025, with a reception at Government House attended by Her Excellency, the Honourable Frances Adamson AC, Mr Rod Bunten, and CEO Marcus Gehrig. Volunteers and foster carers play a vital role in every aspect of our work, from building trust with timid animals and supporting daily operations at our Animal Care Campus, to ensuring our Op Shops are functional and welcoming. Their compassion and dedication drive real change for animals and the people who love them. We're proud to honour their impact at our Animal Care Campus, in our Op Shops, and out in the community.


